## Area of application

## Application and dosage

- Apply the ready-to-use product to the surface by spraying.
- Ensure that surfaces are fully wetted and observe the minimum contact time.
- The product should be used at room temperature.
- Recommended use for surface disinfection (spectrum of effects/exposure times):
- bactericidal, yeasticidal - VAH / EN 13697: high load, without mechanics 5 min.
- tuberculocide (M. terrae) - EN 14348: low exposure 30 s.
- mycobactericidal (M. avium, M. terrae) - EN 14348: low exposure 1 min.
- limited virucidal - EN 14476: low exposure 1 min.
- limited virucidal PLUS - EN 14476: low exposure 3 min.

- Ingredients: 100 g contains: 45.0 g of ethanol. BAuA Reg. No. N-57163, N-57164
- Not on alcohol-sensitive materials such as acrylic glass (PMMA).
- Avoid aerosol formation when spraying, spray from a maximum distance of 10 cm. In case of multiple use of the spray head, pay attention to cleanliness. Contaminated or contaminated spray heads must be disposed of.
