## Area of application

- For water-resistant, colourfast textile coverings and upholstery made of natural hair and synthetics

## Product properties

- Removes the dirt gently, deep into the fibres
- Prevents rapid re-soiling

## Application and dosage

- Always use cold water.
- Pre-treatment: Solution 1:3 to 1:10, leave on for approx. 5 - 10 minutes.
- Spray extract with clear water.
- Consumption: 10 - 50 ml / per m<sup>2</sup>

- Application with spray extractor: Rinse with clean water.
- Stain removal: Pat dry with a cloth.
- Apply fresh application solutions and consume them within 24 hours at the latest.

## Note

- Before application, check the surface for colour fastness in a hidden area.
- Protect from frost.
- Do not soak textile coverings.
- After complete drying, vacuum thoroughly.
- Straighten the pile.
- Changes or variations in colour of the product do not impact on the quality. The product image may differ in colour and shape from the original.
